F406: A NEW ORDER FOR GECI AVIATION

A new order

GECI can confirm its penetration into the surveillance sector with the announcement today of the signing of an order for an F406 surveillance aircraft. This is in addition to the 7 mission aircraft already subject to agreements that are to be delivered to China. This new order confirms the company's prime position in the growing surveillance market and its command of complex system integration.

Building up the order book

Today, the number of F406 aircraft subject to agreements (Letters of Intent, Memoranda of Understanding and Orders) stands at 14.

Meanwhile, the Skylander, the only new western aircraft in the 19 seat niche, is pursuing its planned programme. With its exceptional performance, ability to operate on short and rudimentary runways and very large range the Skylander is generating increasing interest, making the production objective of 1,500 aircraft look perfectly achievable. The number of Skylander aircraft that are currently subject to agreements is 111.

The total number of aircraft subject to agreements – the F406 and the Skylander – stands at 125, representing a potential turnover for our family of aircraft of more than € 500 M.

The first Skylander flight

All of the teams have been mobilised for the Skylander's first flight and the test campaigns, which are to start in the second half of 2012: 200 staff are now working at the Chambley site in Lorraine where the aircraft will be assembled. All of the aircraft equipment manufacturers, system manufacturers, and suppliers have been selected and almost all the aerostructures will produced in France. The final assembly building for the first 4 test aircraft will soon be operational, with receipt of the first stands and tools before the end of 2011. Type certification is planned for the second half of 2013 and the first deliveries of production aircraft will follow.
